


#### **Mission Statement**

- Environmental sustainability is an increasingly important part of how organisations deliver value to their customers. Meaningful, measurable processes are becoming essential to a company's core business model, not just an add on or nice to have intervention but a necessity to meet the rapid growth of environmental, social and governance (ESG) demands of todays society.
- Against this background, The European Lubricating Grease Institute (ELGI), are establishing a Sustainability Technical Consortium to be known as (ELGISTC), this consortium will be formed by Company members, non-company members (eg end users), sister institutes, other consortia and academia.
- The consortium aims to provide its members and the wider industry with the tools, procedures, assessments and framework to develop their procedures and policy to meet the requirements of ESG demands.
- The Consortium will consist of a main Assembly and a range of Task forces to deal in detail with specific aspects of sustainability in the grease industry. Of all the lubricant types available, greases are unique in several ways, e.g.: production, use and disposal, this, in itself, provides the industry with many challenges and while other organisations within our industry have prepared templates and tools to deal with lubricants, it is essential that those tools are appropriate to the grease industry.
- The Consortium will review existing sustainability processes and procedures for the industry and ensure they are adaptable for the grease industry, we do not want to duplicate efforts, but it is important that what we recommend and publish is fit for purpose.
- The Consortium will work closely with other industry bodies to exchange knowledge and share communications to ensure our industry has the resources, a pool of knowledge and the ability to achieve planetary betterment.




















